Subject: Initiation of anti-dumping investigation concerning imports of ‘Welded Stainless-Steel Pipes and Tubes’ originating in or exported from Thailand and Vietnam.

Sir,

I am directed to inform you that an anti-dumping investigation concerning imports of **‘Welded Stainless-Steel Pipes and Tubes’** originating in or exported from **Thailand and Vietnam** has been initiated by the Designated Authority constituted under the Customs Tariff Act, 1975 in respect of the aforementioned subject matter to investigate into the existence, degree and effect of alleged dumping. 2. The exporters and other interested parties known to the Authority to be concerned with the above-mentioned investigation are being requested separately to furnish the relevant information in the form of response to exporter’s questionnaire and offer their comments, if any. However, it is possible that either the addresses are not complete or their email ids are not available or all exporters of the subject goods might not have been intimated directly by the Authority. It is, therefore, requested that this investigation may be brought to the notice of all concerned. The Questionnaire may be downloaded from references given below.

3. The exporters/producers having interest in export of the subject goods to India may be advised to file comments on the claims of confidentiality **within 7 days** and on the scope of the product under consideration, if any, and propose product control numbers (PCNs), if any, **within 15 days from the date of this letter.**

4. Further, such exporters/producers may be advised to furnish information in the form and manner prescribed in the questionnaire to the Authority **within 30 days from the date of this letter**. It is also requested that the exporter/producers may visit the website of DGTR regularly for any updates.
